- A flexible, highly scalable solution with no fixed cost so you can tailor your fleet size to suit your needs
- Consolidated billing, reporting and analytics of vehicle usage

The car sharing solution you choose will depend on your business requirements.

You can either:

1. Have access to the GoGet fleet, with full visibility and control over use of vehicles by your nominated employees, as well as a pay-as-you-go model (Car share services), or
2. Use GoGet technology in your own fleet, reducing administration and removing physical key management requirements (Integrated fleet services)

Manage costs

- Reduce costs by reducing fleet size
 - Allocate vehicles to other locations or decommission as required
- Monitor costs
 - Receive centralised billing and details of cost centres



Improve management and administration of shared vehicles

- Reduce administration
 - Provide keyless entry for drivers / no vehicle handover required
- Increase staff productivity
 - Allow individuals to book themselves with easy 24/7 booking system



Optimise and better utilise shared vehicles

- Receive reporting on fleet usage patterns:
 - Increase fleet when needed by using available pay-as-you-go car sharing vehicles
 - Reduce the fleet or transfer surplus vehicles to other locations
 - Share vehicles across multiple divisions and departments



Manage compliance requirements with shared vehicles

- Change driver behaviour:
 - Identify drivers using shared vehicles and tag bookings so that incidents (e.g. accidents, infringements) can be monitored
 - Establish stricter controls around unauthorised personal use of the vehicles



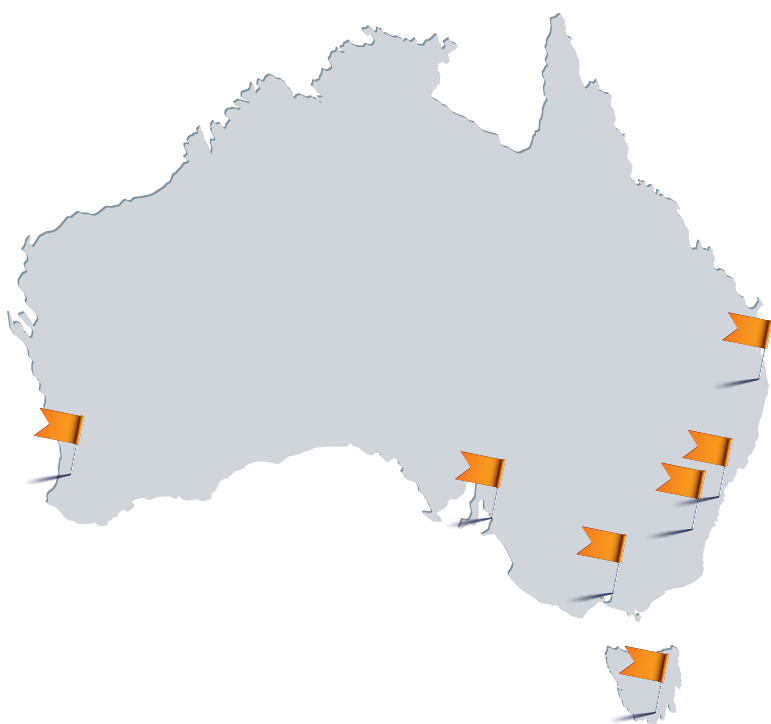
Provide visibility and manage use of alternative transport options
